

## **TERMS OF USE**

Welcome to Price Philanthropies Foundation's-Cardinals Interact website (together with all bulletin board, mailing list or other on-line forum available at **cardinalsinteract.org**, the "Website"), operated by Price Philanthropies Foundation ("Price Philanthropies", "we" or "us") and a third-party operator pursuant to contractual arrangements. We are a 501(c)(3) nonprofit whose mission is to transform the lives of youth and families through grantmaking and youth programs.

By using and participating in the Website, you signify that you have read these terms of use (these "Terms") and agree to be bound by and comply with them.
